**General Comments**

The violations observed during the previous inspection have been corrected.

Recommendations:

It is noted that a small area of ice accumulation was observed on the floor in the walk-in freezer. Ensure that ice accumulation on the floor is monitored to avoid a trip/fall safety hazard.

To help maintain the required holding temperature, it is recommended to limit the number of portions [for unpopular items] that are placed on the serving line at the same time.
