Cafeteria - Three (3) water damaged ceiling tiles observed in alcove above exterior doors (courtyard side). One (1) tile has what appears to be black mold on the face of the tile. Two (2) tiles are bulging and stained. The source of the water damage must be investigated, and the leak must be repaired to stop additional damage and moisture. Ensure that the tiles are replaced and evidence of mold, fungus, and/or mildew is treated and removed.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
