The violations issued during the previous inspection have been corrected.

*Cheese stick sampled from box of cheese sticks at prep table. During the packing of the individual meal bags, ensure that TCS foods are always maintained at 41F or less. It is recommended to work in small quantities and not leave TCS foods at room temperature.

Suds from the 3-comp sink observed coming out of a floor drain and onto the floor. The drain may need to be serviced.
