## I. CALL TO ORDER/ADOPTION OF AGENDA

# II. PRESENTATION OF PROPOSED 2014-2015 TENTATIVE MILLAGE AND TENTATIVE BUDGET FOR ADVERTISING PURPOSES

Mr. Terry St. Cyr, Assistant Superintendent for Finance and Business Services, advised that the purpose of this meeting was for the School Board to consider approval of the three-part advertisement pertaining to the proposed 2014-2015 tentative millage and tentative budget.
