### I. WELCOME/CALL TO ORDER

Mrs. Linda Moultrie, School Board Member, District III, called the Installation Ceremony & Organizational Meeting to order at 5:00 p.m. Mrs. Moultrie welcomed those in attendance and those watching via television or by the "live stream" video via the School District's website. She then acknowledged the presence of the honorable Sheriff David Morgan, Escambia County Sheriff's Office and the honorable Judge Gary L. Bergosh, First Judicial Circuit Court of Florida.

### II. INVOCATION & PLEDGE OF ALLEGIANCE

Mrs. Patricia Hightower, School Board Member, District IV, read a passage about teamwork and leadership entitled *The Flight of the Geese*. She then called for a moment of silence. Mr. Bill Slayton, School Board Member, District V, led the Pledge of Allegiance to the American Flag.

### III. INSTALLATION & REMARKS

Mr. Gerald W. Boone was installed as School Board Member, District II; oath of office was administered by his son, Mr. Kevin Boone.

Mrs. Linda Moultrie was installed as School Board Member, District III; oath of office was administered by her husband, Mr. Anthony Moultrie and Mrs. Donna Sessions Waters, School Board General Counsel.

# IV. ORGANIZATION OF THE BOARD

(Pursuant to Florida Statutes, Section 1001.371)

A. Election of Chairman for 2014-2015

Mr. Slayton nominated Mrs. Patricia Hightower, School Board Member for District IV, to serve as Chairman for 2014-2015. There being no further nominations, the Superintendent called for the vote. The nomination of Mrs. Hightower to serve as Chairman for 2014-2015 carried unanimously.

B. Election of Vice Chairman for 2014-2015

Mrs. Hightower nominated Mr. Bill Slayton, School Board Member for District V, to serve as Vice Chairman for 2014-2015. There being no further nominations, the Superintendent called for the vote. The nomination of Mr. Slayton to serve as Vice Chairman for 2014-2015 carried unanimously.

C. Designation of Date, Time, and Location of Regular Monthly Workshop and Meeting

Motion was made by Mr. Bergosh and seconded by Mrs. Moultrie, to maintain the current schedule of monthly workshops and meetings, with:

Motion to maintain the current schedule of monthly workshops and meetings carried unanimously.

### D. Appointment of Parliamentarian

Motion was made by Mrs. Moultrie and seconded by Mrs. Hightower, to appoint the School Board General Counsel, Mrs. Donna Sessions Waters, as Parliamentarian. Motion carried unanimously.

E. Selection of Parliamentary Procedure

Motion was made by Mr. Slayton, seconded by Mrs. Hightower, to designate the latest version of *Robert's Rules of Order Newly Revised* as the parliamentary procedure to be followed for the conduct of official business of the School Board. Motion was approved unanimously.
