b. Stellar Employee of the Month

The Superintendent made the following announcement: It is my pleasure to announce that the Stellar Employee Award for the month of October is being presented to Vernice Hale. Vernice Hale is a custodian at the J.E. Hall Center. Many of the employees within this complex do not know her as "Vernice Hale," they affectionately know her only as "Ms. V." e. Recognition of State-Level ESOL Teachers

The Superintendent made the following announcement: Tonight we would like to recognize two exceptional ESOL teachers. The first award recognition is for the 2014 Florida Sunshine State Outstanding Teacher of English for Speakers of Other Languages (TESOL) Educator – Doreen Wells of Ensley Elementary School. Ms. Wells is not only an innovative first and fifth grade ESOL teacher, but she is an ESOL team leader at Ensley Elementary and a National Board Certified Teacher. Ms. Wells' achievements include the ability to inspire students to continually excel in academic classes through innovative approaches such as the "Language Acquisition through Arts, Science, and Technology (LAAST)" and the Whole Brain approach in ELLs. Ms. Wells incorporates technology in teaching and learning and her professional leadership extends outside the walls of her classroom. One of her outstanding accomplishments is for her involvement in the development of the District's Grading ELLs policy which is now a part of the Student Progression Plan. Ms. Wells is also a recipient of the 2005-2006 Escambia County Council of Elementary Teachers of Mathematics Teacher of the Year. HER principal Jane Cecil describes Ms. Wells as "motivated and committed to the success of her children and colleagues. She exemplifies devotion and compassion to the advancement of all children at Ensley Elementary." Tonight's second recognition is for the 2014 Bea Palls Diversity Educator Award Recipient – Laura Figueroa, ESOL Itinerant Teacher for the School District. Ms. Figueroa is a dedicated ESOL teacher who works tireless daily with students, parents, teachers, and administrators. Ms. Figueroa methodically plans each engaging lesson for each individual student. She has used ESOL strategies that combine language acquisition and academic vocabulary. Ms. Figueroa has built positive relationships with students and their families through school meetings, phone conversations and home visits. In addition, Ms. Figueroa has served on numerous committees and has planned professional development and family night activities. Ms. Figueroa serves as a translator for IEP meetings and her services are requested on a daily basis for parent conferences. Many teachers within our district have greatly benefitted from Ms. Figueroa's knowledge as she shares countless materials and offers successful strategies to use with ell students. Furthermore, Ms. Figueroa has taught after-school adult classes where parents have flourished by learning conversational English and critical job interviewing skills. Ms. Figueroa is always willing to go the extra mile and always manages to do all of this with a smile.

Recommend that consistent with the decision of the due process committee, student discipline number 15-16-862 be expelled from all public schools of Escambia County for the remainder of the 2014-2015 school year and all of the 2015-2016 school with the option to enroll, if qualified and if space is available, in an alternative educational program exclusive of regular school placement. Placement to be at the discretion of the Superintendent and to be available as an alternative during the full expulsion time frame.

Motion was made by Mr. Slayton and seconded by Mr. Bergosh, to accept the Superintendent's recommendation for student discipline as outlined in Item V.d.2.A., *Disciplinary Reassignment* and Item V.d.2.B., *Expulsions*. Motion carried 4 to 0, with Mr. Boone absent for vote.

 - A. Recommend that employee #0000013008 be suspended without pay for five (5) working days beginning Wednesday, October 22, 2014, and complete anger management counseling based on misconduct as more specifically identified in the notice letter to the employee.

 - D. Recommend that employee #0000021135 be suspended without pay for one (1) working day beginning Wednesday, October 22, 2014, based on misconduct as more specifically identified in the notice letter to the employee.
