A copy of the Charter School Quarterly Report for March 2016 (as amended) was provided to School Board Members prior to this session. Ms. Vicki Mathis, Director of Alternative Education, reported that the only school with a Progress Monitoring Plan in place was Jacqueline Harris Preparatory Academy. She noted

that the School Board was previous noticed of an isolated "bus incident" that caused the need for the monitoring plan. There were no questions posed by School Board Members regarding any of the information outlined in the Charter School Quarterly Report for March 2016 (as amended).

The Superintendent mentioned that Ms. Lewis had recently received the Champion of Education Award from the United Negro College Fund Group. The Superintendent and School Board congratulated Ms. Lewis for her leadership in the education of students at Jackie Harris.

Mr. Bergosh noted that in the past, he had made it clear that he was no longer interested in being a member of the Florida School Boards Association (FSBA). He noted that there was legislation currently being considered, that would change the assessment of membership association dues which were paid with public funds, giving an individual public officer the option to refrain from joining such membership association. In light of that proposed legislation and given that the FSBA 2016-17 annual dues were not due until July 1, 2016, Mr. Bergosh requested that this item be postponed until the following month as he believed that by that time, the legislation perhaps would be passed and would allow him to pull out his portion of those dues and redirect those funds elsewhere.

10. Emergency Purchases - February 2016 Tornado

The Superintendent advised that this \$185,531.85 in emergency purchases represented expenses that were over his spending limit and as such, required School Board approval. He noted that the total amount of damage incurred by the recent tornado was actually around \$250,000.00. Mr. Shawn Dennis, Assistant Superintendent for Operations, advised that the majority of the damages were to Workman Middle School. He noted that a roof peel-back at Workman had affected four classrooms in terms of flooding and in addition, there were awning peel-backs that resulted in structural implications.
