# THE SCHOOL BOARD OF ESCAMBIA COUNTY, FLORIDA

#### MINUTES, DECEMBER 15, 2015

The School Board of Escambia County, Florida, convened in Regular Meeting at 5:30 p.m., in Room 160, at the J.E. Hall Educational Services Center, 30 East Texar Drive, Pensacola, Florida, with the following present:

#### I. CALL TO ORDER

Mr. Slayton called the Regular Meeting to order at 5:30 p.m. He welcomed everyone in attendance to the regular monthly meeting of the Escambia County School Board and thanked them for their interest in public education.

Mr. Boone delivered the invocation and led the Pledge of Allegiance to the Flag of the United States of America.

#### b. Adoption of Agenda

Mr. Slayton advised that Florida Statutes and School Board Rule required that changes made to an agenda after publication be based on a finding of good cause determined by the person designated to preside over the meeting and stated in the record. Mr. Slayton said he, as School Board Chair, had determined that the Superintendent's recommended changes to the December 15, 2015 Regular Meeting agenda had been made for good cause. Motion was made by Mrs. Moultrie and seconded by Mr. Boone, to adopt the agenda (*as amended*). Motion carried 4 to 0, with Mrs. Hightower absent for vote.

#### 2. Stellar Employee of the Month

The Superintendent made the following announcement: Thank you for the opportunity to announce to you that Aurelia Montanez has been named the Stellar Employee of the month for December. I understand that Mrs. Montanez is one of the most positive, encouraging people employed in "Bulldog County" at Bailey Middle School. Mrs. Montanez is the Maintenance Crew Supervisor and is a powerhouse of energy and boundless enthusiasm. She treats everyone with love and respect and is in constant motion, smiling at everyone. Mrs. Montanez makes sure that the large campus is transformed by keeping it clean and in working order. Mrs. Montanez's contributions to the Bailey family have changed over the past 12 years, as circumstances in her own life presented challenges that some people would see as barriers, however, through her determination and dedication, Mrs. Montanez found these barriers as opportunities. Prior to being employed by the District, Mrs. Montanez's husband and father to their two little girls went into the hospital for a routine procedure, and never came back to their beautiful life. Mrs. Montanez never imagined she would be a young window with two little girls to raise by herself and having to do so living so far from her family in Puerto Rico. Undaunted, and with a love of children at Bailey Middle School who are facing their own challenges, Mrs. Montanez began working at Bailey Middle School as a paraprofessional assisting teachers with exceptional children. In this capacity, parents, children, and teachers were all inspired by Mrs. Montanez's dedication and ability to break down difficult academic skills into manageable parts, all while making the children feel loved and cared for. Circumstances in 2005 led to an unexpected change as Mrs. Montanez transferred from being a beloved teaching paraprofessional to a custodian where her work ethic and positive attitude were clearly evident. She worked as part of the custodial team from 2005 until 2014, when Bailey's Head Custodian was overcome by a sudden and serious illness. Making the transition from team member to their supervisor was definitely a challenge, but one which Mrs. Montanez's leadership skills and the mutual respect she had gained made her a natural supervisor. Her willingness to work harder than anyone else has served her well as the "boss." Mrs. Montanez never asks a custodian to perform a task she has not tried and completed herself. Her organizational skills are natural, effective, and reflect her remarkable work ethic. Mrs. Montanez's infectious positivity and unparalleled dedication to her work all contributes to her being named the Stellar Employee for the month of December. The Superintendent and School Board congratulated Mrs. Montanez for being selected as the Stellar Employee for the month of December. To acknowledge her achievement and recognize her stellar performance, Mrs. Montanez received a plaque and a pin from the School District and a check in the amount of \$100 from Members First Credit Union.
