I. CALL TO ORDER

Mr. Slayton called the Regular Meeting to order at 5:30 p.m. He welcomed everyone in attendance to the regular monthly meeting of the Escambia County School Board and thanked them for their interest in public education.

a. Invocation and Pledge of Allegiance

Dr. Ted Traylor, Pastor of Olive Baptist Church, gave the invocation. Mr. Slayton led the Pledge of Allegiance to the Flag of the United States of America.

b. Adoption of Agenda

The Superintendent noted the changes that had been made to the agenda since initial publication. Mr. Slayton advised that Florida Statutes and School Board Rule required that changes made to an agenda after publication be based on a finding of good cause determined by the person designated to preside over the meeting and stated in the record. Mr. Slayton said he, as School Board Chair, had determined that the Superintendent's recommended changes to the August 16, 2016 Regular Meeting agenda had been made for good cause. Motion was made by Mr. Bergosh and seconded by Mrs. Moultrie, to adopt the agenda (*as amended*). Motion carried unanimously.

 - 1. PTA Presentation

Ms. Michelle Salzman, President of the Escambia County Council PTA (ECCPTA), gave a brief report on the recent and upcoming events and activities of the PTA.

2. Stellar Employee of the Month

The Superintendent made the following announcement: It is my pleasure this evening to announce that the Stellar Employee for the month of August is Ms. Teresa Pace, Administrative Secretary at Ferry Pass Middle School. Ms. Pace is very dedicated to her job and goes above and beyond each day. She has been known to capture a stray cat in a classroom, corner a lizard in an office, fill in for the crossing guard, and help during lunch duty solidifying that she is a team player and chooses to serve in any way necessary. Ferry Pass Middle School has over 1,000 students, 70 teachers, and 10 employees who serve as support staff. She keeps up with this fast pace environment and assists all employees with anything they may need. The Data Clerk was diagnosed with an illness that required difficult treatments, which led to some time away from the office and her work responsibility. Ms. Pace stepped up to learn the varying aspects of the data clerk position so that her co-worker did not have to worry and the school did not have to miss a beat. It has been said about Ms. Pace that she has a heart of gold and puts her heart into her job every day. She is stellar for excellent work and dedication to the staff at Ferry Pass Middle and she exemplifies the pillars of "people" and "service." It is for these reasons, and many others, that Ms. Pace has been selected as our Stellar Employee for the month of August, 2016. In recognition of her stellar performance, Ms. Pace received a plaque from the School District and a check in the amount of \$100 from Members First Credit Union.

3. Workman Middle School TSA (Technology Student Association National Champions)

The Superintendent made the following announcement: *The Technology Student Association National Conference this year was held in Nashville, Tennessee. Over 6,000 middle and high school students from across the nation competed in over 65 STEM competition such as technology problem solving, debating technological issues, geospatial technology, and structural engineering. Escambia County is able to boast about the fact that we had students from Workman Middle School walk away with awards from this national competition. The following students placed 10th in this national competition in the leadership strategies category: Luke Allen, Aiden Enfinger, and Dannon O'Brien. The following students placed* 8th *in inventions and innovations: Isabella Kunze, Aidan Enfinger, Dannon O'Brien. And in technical design, we have two students who were awarded first place in the entire nation! They are: Jackson Allen and Dustin Meyer. Please let us also recognize, Kim Ridings, their teacher, who because of her dedication and leadership, guided these students into the successes they have achieved.*

4. State SRO of the Year Award and Escambia SRO Best in State

The Superintendent made the following announcements:

State SRO of the Year Award - It is my honor to announce to you the School Resource Officer of the Year for the entire State of Florida – Ernest Ward Middle School's School Resource Officer, Senior Deputy James Gill. Senior Deputy Gill has been in the Escambia County School District School Resource Program for more than 12 years, however, his law enforcement career spans approximately 40 years. While he works hard protecting the students, faculty, and staff within the school in which he is assigned, he also gives selflessly of his time and many times his finances to mentor and help students in need. Students describe him as a confidant and a friend who has an open door policy for all. Senior Deputy Gill can be found using his personal money to take care of the needs of the students he knows come from a background of poverty. He has been known to pay for lunches, trip fees, club dues, yearbooks, and even paid for Christmas shopping. The relationships that Senior Deputy Gill has established with students and young people do not just end at the middle school. When these middle school students graduated to high school, their sentiment and desire was that Deputy Gill go with them! Senior Deputy Gill plays a crucial role in the education of children for the Escambia County School District. He is also breaking down any barriers that exist between law enforcement and the young people in our county. It is for these reasons, and many more, that makes it very evident that Senior Deputy Gill is the School Resource Office of the Year for the State of Florida!

Escambia SRO Best in State – It is my honor to inform the School Board Members, staff, and guests that the Escambia County Sheriff's Office School Resource Unit has been named the Florida Association of School Resource Officers Agency of the Year. In 1996, the Escambia County Sheriff's Office was one of the first agencies in northwest Florida to initiate a School Resource Officer Program in the state. This program began with one officer at an inner-city high school. Since that time, the program has flourished to include 15 officers, 1 K-9, and three supervisors, covering our community which has over 300,000 residents and 41,000 students. Our SRO's will take the time to study a disruptive situation, provide their findings to the school administration and staff, and as a team work together to determine the best course of action for a positive outcome. Just like Senior Deputy Gill, many of the men and women who serve as SRO's in our schools are dedicated to the task at hand and provide a safe school environment while serving as strong role models. School Resource Officers also create and present numerous presentations aimed at modifying poor behavior. School Resource Officers, because of their willingness to establish relationships have the ability to encourage a student to know their life has purpose. Our School Resource Officers can be seen outside of the school work day at many community events further solidifying their involvement in our community as a whole. Please accept this certificate as a way to acknowledge the hard work and dedication of every resource officer.

5. Principal of the Year Award/Assistant Principal of the Year Award

The Superintendent made the following announcements:

Principal of the Year Award – It is my pleasure this evening, to announce that Mr. David Williams has been selected as the Escambia County School District's Outstanding Principal of the Year. You may not know this about Mr. Williams, but he has the distinct privilege of having graduated from Pensacola High School in 1977. He began teaching and coaching at Pensacola High School in 1986. He then became assistant principal at Pensacola High School in 2004, and then ultimately, principal in 2008. Mr. Williams' leadership abilities set a stellar example for our school district. He is also a leader within the community and amongst his peers. Under his direction, Pensacola High School is excelling because he accepts no excuses for failure and sets high expectations for all. Under his leadership, the focus has been on meeting the individual needs of his students regardless of their background and ability. As a result, the graduation rate at Pensacola High School continues to increase with the 2016 graduation rate currently at 74.6%. In just two years, the graduation rate has increased 13.1% and the African-American male graduation rate is at an all-time high of 61.1%. The Escambia County School District is very proud of Mr. David Williams and I am honored to recognize him as the outstanding principal of the year.

<u>Assistant Principal of the Year Award</u> – It is also my pleasure this evening to announce that Catrena Fieg has been selected as the Escambia County School District's Outstanding Assistant Principal of the Year. As an elementary assistant principal, Mrs. Fieg has helped to make Helen Caro Elementary School a place in which the community, faculty, and students take great pride. Mrs. Fieg is respected by her peers, parents, and students. Her dedication to excellence and the love of her school community make her an excellent role model for all assistant principals in our district. Mrs. Fieg has a unique trait that assists her success at an elementary school. An elementary school that can boast about its high military student presence. She is a military wife, which allows her to understand the challenges that children of military parents face. The Escambia County School District is extremely proud of the accomplishments of Mrs. Catrena Fieg and I am honored to recognize her as the outstanding assistant principal of the year.
