#### - <u>Update on Transportation Problems</u> – *Slayton*

(NOTE: *This matter was discussed at previous workshop sessions.*) At the request of Mr. Slayton, the Superintendent and Mr. Robert Doss, Director of Transportation, gave a brief update on the School District's efforts to recruit additional school bus drivers. The Superintendent said the School District was making progress and though the situation was no longer as desperate as it had been in months past, there was certainly still a need for additional drivers. Mr. Rob Doss, Director of Transportation, reported that the Transportation department had begun the school year forty (40) drivers short, but currently was down to twenty-two (22) short. Furthermore, five (5) additional drivers would be added within the next week, ten (10) individuals were beginning class the next week, eight (8) were currently in the "behind the wheel" phase of training, and four (4) others were currently obtaining CDL permits.

- FSBA Legislative Platform - Hightower

As the School Board's liaison to the FSBA Legislative Committee, Mrs. Hightower asked fellow School Board Members for input on the FSBA's annual Legislative Platform, which would be discussed at the October 26 Legislative Committee meeting. School Board Members expressed no concerns with the Platform as presented; however, the Superintendent requested the School Board ask the FSBA to consider an item addressing the current requirements for square footage for school construction.

#### Strategic Plan - Superintendent

(NOTE: This matter was previously addressed at a previous School Board session. School Board Members received a copy of the 2016-17 Strategic Plan as revised for 2017-18 prior to this session.) Representatives of the Strategic Planning Committee introduced a new use-friendly format for the Strategic Plan and reviewed the various changes that had been made to objectives, metrics, and goals for each pillar. The Superintendent said the 2017-18 Strategic Plan would be submitted for School Board approval on the November Regular Meeting agenda.
