Mr. Boone called the Regular Workshop to order at 2:00 p.m.

- Career Academy Presentation - Pine Forest High School New Media Academy - Superintendent

Students enrolled in the New Media Academy at Pine Forest High School addressed the School Board regarding their experiences in this program.

- FHSAA Football Playoffs – Slayton*

*Mr. Slayton submitted this topic for discussion, and although he was not present, the Superintendent decided to move forward with the presentation since staff was already prepared to do so. Mr. Roger Mayo, District Athletic Director, reviewed information regarding the new Florida High School Athletics Association (FHSAA) football playoff structure, including how teams would now earn points, and the qualifying criteria for the point system.

- School Crossing Guards - Adams

Upon inquiry by Mr. Adams, Mr. Shawn Dennis, Assistant Superintendent for Operations, explained how the School District administration determines whether a school requires the assistance of a crossing guard. He noted that a number of factors, including location and traffic volume, were considered when making that determination.

- <u>Warrington Middle School Turnaround Plan</u> – Superintendent [<u>Handouts</u> provided to School Board Members]

The Superintendent updated the School Board on the status of the Warrington Middle turnaround situation. The Superintendent advised that, according to House Bill 7069, the School District was limited to only three options if Warrington Middle did not earn a school grade of $\it C$ or higher in 2018:

REASSIGN - Reassign students to another school and monitor the progress of each reassigned student.

CHARTER - Close the school and reopen the school as one or more charter schools, each with a governing board that has a demonstrated record of effectiveness.

EXTERNAL OPERATOR - Contract with an outside entity that has a demonstrated record of effectiveness to operate the school.

The Superintendent advised that contracting with outside entity was the option selected; and School District staff would work through the Department of Education to qualify Turnaround Solutions, Inc. as an external operator. (Over the last couple of years, the School District had invested in the services provided by Turnaround Solutions, Inc. for Warrington Middle and the increase in student performance had been steady.) The Superintendent noted however, that should Turnaround Solutions not be qualified as an external operator, the School District would be forced to identify a different entity.
