VII. FINAL ADOPTION OF MILLAGE RATES FOR FISCAL YEAR 2018-2019

1. Required Local Effort

2. Discretionary – Operating

Motion by Mr. Slayton, seconded by Ms. Hansen, to adopt the 2018-2019 Discretionary – Operating millage rate at 0.748 mills, carried unanimously.

3. Capital Outlay

Motion by Mr. Slayton, seconded by Mr. Adams, to adopt the 2018-2019 Local Capital Improvement (Capital Outlay) millage rate at 1.377 mills, carried unanimously.

4. Total Millage

Motion by Mr. Slayton, seconded by Mrs. Hightower, to adopt the 2018-2019 Total Millage at 6.325 mills, carried unanimously.

VIII. FINAL ADOPTION OF DISTRICT SCHOOL BUDGET FOR FISCAL YEAR 2018-2019

1. General Fund

Motion by Mr. Slayton, seconded by Mrs. Hightower, to adopt the 2018-2019 General Fund budget of \$359,065,951.60, carried unanimously.

2. Special Revenue – Food Service

Motion by Mr. Slayton, seconded by Ms. Hansen, to adopt the 2018-2019 Special Revenue – Food Service budget of \$29,188,485.93, carried unanimously.

3. Special Revenue – Other Federal Programs

Motion by Mr. Slayton, seconded by Mr. Adams, to adopt the 2018-2019 Special Revenue – Other Federal Programs budget of \$35,380,227.10, carried unanimously.

4. Debt Service Funds

Motion by Mr. Slayton, seconded by Ms. Hansen, to adopt the 2018-2019 Debt Service Funds budget of \$20,871,957.21, carried unanimously.

5. Capital Project Funds

Motion by Mr. Slayton, seconded by Mr. Adams, to adopt the 2018-2019 Capital Project Funds budget of \$138,177,126.96, carried unanimously.

6. Internal Service Funds

Motion by Mr. Slayton, seconded by Mrs. Hightower, to adopt the 2018-2019 Internal Service Funds budget of \$60,927,373.77, carried unanimously.

7. Total Budget

Motion by Mr. Slayton, seconded by Ms. Hansen, to adopt the 2018-2019 Total Budget of \$643,611,122.57, carried unanimously.
