I. CALL TO ORDER

Mrs. Hightower welcomed everyone in attendance as well as those watching via live streaming and thanked them for their interest in public education. She called the Regular Meeting to order at 5:30 p.m.

a. Invocation and Pledge of Allegiance

Mr. Slayton asked everyone to take a moment to reflect on the safety and education of all students. He also solicited prayers for the family and friends of Sean Alexander Banks, a 15-year old Tate High School sophomore and his 22-year old sister Antoinette Marie McCoy, who were killed in a tragic car crash on January 12, 2019. Following the moment of reflection and prayer, Mr. Slayton asked everyone to join him in reciting the Pledge of Allegiance to the American Flag.

b. Adoption of Agenda

The Superintendent listed all changes made to the agenda since initial publication. Mrs. Hightower advised that Florida Statutes and School Board Rule require that changes made to an agenda after publication be based on a finding of good cause, as determined by the person designated to preside over the meeting, and stated in the record. Mrs. Hightower said she, as School Board Chair, had determined that the Superintendent's recommended changes to the January 15, 2019 Regular Meeting agenda were for good cause, as she believed that all changes had been discussed at the January 11, 2019 Regular Workshop. Motion by Mr. Adams, seconded by Mr. Slayton, to adopt the agenda *as amended*, carried unanimously.

1. PTA Presentation

Ms. Tori Woods, President of the Escambia County Council PTA (ECCPTA), gave a brief report on recent and upcoming events and activities.

2. Stellar Employee of the Month

The Superintendent made the following announcement: *I am pleased to inform you that the Stellar Employee for the month of January is Ricky Newman. Ricky Neumann has been with the District for five years and he is assigned to Beulah Middle School which opened this school year. 3. PBIS Model School Awards

The Superintendent made the following announcements:

It is my honor to present to you the 2017-2018 Positive Behavior Interventions and Support (PBIS): MTSS Model School Recipients. This year we have twenty-one (21) schools that have met the requirements to become a PBIS Model School. It should be noted that we have more model school award recipients this year than in any other year in the past. PBIS is the application of evidence-based strategies and systems to assist schools to increase academic performance, increase safety, decrease problem behavior, and establish positive school cultures. This process is a team-based approach that relies on a strong collaboration between families and professionals from a variety of disciplines regardless of the level implemented. We would like to begin by

recognizing our two Bronze Level Model Schools. In order to receive Bronze status, schools must demonstrate an overall effectiveness of tier one behavioral data and use this data to develop a plan of action that ensures equitable behavioral outcomes for all students.
