It was agreed that a letter would be drafted on behalf of the School Board and School District requesting inclusion as partners in Escambia County's design and review committee; and requesting that reasonable acreage set aside be included in the plan for the purpose of constructing a 1200 student school (cost to be borne entirely by the School District).
