The Superintendent read the following resolution:


WHEREAS, bullying is physical, verbal, sexual, or emotional harm or intimidation intentionally directed at a person or group of people; and

Dr. Edler proceeded to outline her concerns with the contract, which included the response Attorney Hammons previously made in reference to the temporary housing allocation ("if the money is not spent, he can do what he wants to do with it"). Dr. Edler stated, to allow this would be poor management of the people's money. After much discussion, Mr. Slayton offered a motion to call the question, which was seconded by Mr. Adams and approved 4 to 1, with Dr. Edler voting "No." Motion to approve *as amended* Item V.c.1., *Appointed Superintendent Contract* (Dr. Timothy Smith), carried 4 to 1, with Dr. Edler voting "No."
