- District Communication with Parents Regarding COVID 19 and School Events - Hightower

In response to concerns expressed by Mrs. Hightower, the Superintendent confirmed that reopening information was accessible via link (<u>http://escambiaschools.org/reopening</u>) from the home page of the School District website. He was to confirm that each school's webpage also included a link to that information.

- <u>Update on Legal Services</u> – *Hightower* 

(*Previously discussed at the July 20, 2020 Regular Workshop*) Mrs. Hightower advised the School Board that Mrs. Waters would remain on leave through the end of August. Mrs. Hightower also advised that Mrs. Waters had offered to work from home; however, School Board Members did not wish to grant her the ability to do so. There was discussion about the possibility of retaining separate counsel to represent the School Board while Mrs. Waters remained on leave. Currently, the Superintendent's counsel, Mr. Joseph L. Hammons, was also providing counsel for the School Board; nowever, should a conflict arise between the School Board and Superintendent, the School Board would need to obtain separate counsel for the School Board for that matter.
