Motion was made by Mr. Bergosh, seconded by Mr. Gindl, to approve the Superintendent's 6-7-8 Plan. Mrs. Carolyn Spooner, Director of Secondary Education, gave a brief PowerPoint® presentation regarding the impact of the 6-period day on a student's schedule (including required courses and the number of periods that a student would have for elective courses). (NOTE: *This presentation was previously given at the January 13, 2006 Regular Workshop.*) Mr. Bergosh expressed support for the Superintendent's 6-7-8 plan (6-period day) due to the fact that the District was only funded by the State for a 6-period day. Upon inquiry by Mrs. Stidham, Mrs. Spooner clarified that the 6-period day would not apply to the specialized programs at West Florida Technical High School or the International Baccalaureate (IB) Program at Pensacola High School; instead there would a change from an 8-period day to a 7-period day in order to maintain the integrity of those programs.
