INVOCATION AND PLEDGE OF ALLEGIANCE

Dr. Alan Scott gave the invocation and Mr. Keith Leonard led the Pledge of Allegiance to the United States of America.

PUBLIC FORUM

Mr. Bergosh called the Public Forum to order at 5:35 p.m.

(Mr. Bergosh requested that the Superintendent have his staff confer with Ms. Weldamoyer regarding her concerns.)

I. CALL TO ORDER/ADOPTION OF AGENDA

Mr. Bergosh called the Regular Meeting to order at 5:50 p.m. The Superintendent listed the additions, deletions, amendments and corrections to the agenda. Motion was made by Mr. Gindl, seconded by Mrs. Hightower, to adopt the agenda (as amended). Mrs. Stidham requested the addition of an item under "Items from the Board" entitled, "Discussion of the Superintendent's Implementation of the School Attendance Zone Advisory Committee (SAZAC)." Mr. Bergosh did not believe that it was appropriate to add such an item to the agenda for the current meeting; he suggested that the issue be handled instead, with one-on-one visits between individual Board Members and the Superintendent. Mrs. Stidham then requested the addition of item under "Items from the Board" entitled, "Request to Schedule a Special Board Workshop to Discuss the Superintendent's Implementation of the School Attendance Zone Advisory Committee (SAZAC)." Again, Mr. Bergosh did not believe that it was appropriate to add such an item to the agenda for the current meeting; he questioned the General Counsel as to whether or not it was appropriate for agenda items to be added at the table. In order to confer with General Counsel regarding this issue. Mr. Bergosh requested a brief recess. The Regular Meeting recessed at 5:58 p.m. and reconvened at 6:05 p.m., with all Board Members, the Superintendent, and Mrs. Odom present. Mr. Bergosh advised that during recess, the Superintendent had offered to hold a Special Workshop during the upcoming week in order to provide Board Members with a forum for discussing his implementation of SAZAC. Regarding changes to the agenda, Mrs. Odom referred to School Board Rule 6Gx17-1.06(5)(a) which read: Any changes to the agenda after it has been made available can only be made for good cause as determined by the School Board and stated in the record. In advance of any meeting, the Superintendent shall advise School Board Members in writing about any substantive changes made to agenda items between the time the agenda and back-up materials are published and Board action on the matter. The Superintendent shall provide the written notice(s) required by this section with as much advance notice as is possible under the circumstances. Mrs. Odom believed that Mrs. Stidham's request to add an item to the current meeting agenda was permissible; however, Mrs. Stidham would need to provide good cause for the request and the Board would then need to decide whether or not they wished to grant that request. Mrs. Stidham clarified that the intent of her request was to allow for a forum in which Board Members and the Superintendent could engage in discussion in an effort to clarify both SAZAC's charge and the process that SAZAC would follow in carrying out that charge. Upon inquiry by Mrs. Stidham, the Superintendent agreed that the Special Workshop could be held in the afternoon rather than the morning to allow for better public attendance. Mr. Bergosh

noted for the record, that he had "always voted and made motions to have all meetings after normal working hours to ensure public participation." Mrs. Stidham accepted the Superintendent's offer to hold a Special Workshop; she withdrew her request for the addition of an item under "Items from the Board" entitled, "Discussion of the Superintendent's Implementation of the School Attendance Zone Advisory Committee (SAZAC)." Motion to adopt the agenda (as amended), was approved unanimously.
