Motion was made by Mr. Bergosh, seconded by Mrs. Brown-Curry, to approve this item. (NOTE: Throughout the discussion on this item, there were also references to Item V.C.1.g.9 which involved a similar recommendation of removing a supervisor ESP position and replacing it with a Professional position.) Mr. Shawn Dennis, Assistant Superintendent for Operations, began by explaining that there were over 70 supervisortype ESP positions that were currently in the same bargaining unit as the employees that they supervise; this situation resulted from a contract merger that had occurred several years ago, in which the supervisor bargaining unit was combined with two other bargaining units to form just one overall unit. Mr. Dennis advised that the problem with the current situation was that according to the ESP bargaining agreement, no member of the bargaining unit may supervise another member of the same bargaining unit; and according to Florida Statutes, no member of a bargaining unit may file a grievance against another member of the same bargaining unit. He noted that the proposed recommendations (outlined in this item and in Item V.C.1.g.9) would begin the process of correcting this situation by removing these two ESP supervisor positions and replacing them with two Professional positions. He noted however, that there were still over 70 additional supervisor-type ESP positions, currently filled by permanent employees, that would eventually need to be replaced with Professional positions; a significant issue that the Superintendent and his staff would be addressing. (It was noted that these were the first supervisor-type positions that had become vacant since the merger took place.)

*Mr. Pitman also chose express his opposition to Item V.C.1.g.9 at this time.

In response to comments made by several speakers, Mrs. Odom advised that if the Board did approve the recommendation to remove the two ESP supervisor positions from the bargaining unit, then the Union, if they disagreed with that decision, did have the option of filing a petition for unit clarification with the Public Employees Relations Commission (PERC). She noted that if a petition was filed, PERC would make the final determination of whether these positions should remain in or be removed from the bargaining unit.

There was discussion as to whether Union representatives had previously stated that they would request a unit clarification or whether Union representatives and District staff had agreed to jointly request a unit clarification; regardless, it was noted that a request had not yet occurred.

Mrs. Hightower believed that the Board should support this recommendation if for no other reason than so that the Union may file a petition with PERC and the matter could be settled legally; then the District and the Board would know whether to move forward

with addressing the over 70 additional supervisor-type ESP positions that were in the same situation.

Motion was approved 3 to 1, with Mrs. Brown-Curry voting "No" and Mr. Boone absent for vote.

9. Approve Facilities Manager-Capital Improvements job description on the Professional Salary Schedule. Amend page 16 (Facilities Planning) of the 2006-2007 Department Personnel Planning Document: delete one Construction/Maintenance Supervisor II ESP position and add Facilities Manager-Capital Improvements Professional position. (NOTE: This item was pulled due to a speaker who had requested to address the Board regarding this item; however, the speaker, Mr. David Pittman, chose to address this item during the discussion of Item V.C.1.g.8). Motion by Mrs. Hightower, seconded by Mrs. Brown-Curry, to approve this item, carried 4 to 0, with Mr. Boone absent for vote. Mrs. Hightower called for a revote at the request of Mrs. Brown-Curry who had registered her vote incorrectly. Motion was approved 3 to 1, with Mrs. Brown-Curry voting "No" and Mr. Boone absent for vote.

2. Approval and Implementation of the Escambia STAR Performance Pay Plan

Motion was made by Mrs. Hightower, seconded by Mr. Bergosh, to accept the Superintendent's recommendation for approval and implementation of the Escambia STAR Performance Pay Plan.

The following speakers requested to address the Board regarding their opposition to this item:
Bill Vincent, representative, Escambia Education Association Bargaining Council
Gail Husbands, President, Escambia Education Association
Tom Wazlavek, Executive Director, Escambia Education Association

Mr. Malcolm Thomas, Director of Evaluation Services, gave a brief review of the proposed STAR performance pay plan (as outlined in backup documentation), highlighting items such as methods for determining student achievement and methods for ranking instructional personnel.

Mrs. Brown-Curry indicated that she would not support the proposed STAR plan, as she did not believe it to be equitable to all teachers from all schools in the District. Primarily she was concerned about teachers at high-poverty inner-city schools, who may not have the adequate resources to ensure that their students received an efficient education. Staff members responded to Mrs. Brown-Curry's concerns by pointing out, that in fact, most high-poverty inner-city schools did receive sufficient funds from Title I to acquire the necessary resources for efficiently educating students.

It was noted that regardless of whether the proposed STAR plan was approved, the State had mandated that school districts develop and implement some type of a performance pay plan. If the District did choose to submit a STAR plan, and if it was approved by the State, then the State would provide \$2,100,000 for implementation; however, if the District did not choose to submit a STAR plan, then the District would still be required to develop, implement, and provide the funds for some type of performance pay plan.

Upon inquiry by Mr. Bergosh, Dr. Alan Scott, Assistant Superintendent for Human Resource Services, confirmed that the District did currently have a Board-approved performance pay plan; however, the current plan had a very cumbersome application process, which to date, no teacher had ever completed. He noted that from all indications, the District's current performance pay plan did not meet the State's requirements.

For the record, it was noted that the deadline for submitting the Escambia STAR plan to the State Board of Education for approval was March 1, 2007.

The following speakers requested to address the Board regarding their opposition to this item: Cathy Boehme; Chris Were; Robert Husbands; and Arlene Costello.

Mrs. Hightower and Mr. Bergosh indicated that they would support the approval of the proposed STAR plan, primarily because there were only two options: either approve the STAR plan and if approved by the State, then the State would provide the funding; or develop and implement some other type of performance pay plan and the District would have to provide its own funding.

Motion carried 3 to 1, with Mrs. Brown-Curry voting "No" and Mr. Boone absent for vote.

3. Student Recommendations

Motion by Mrs. Hightower, seconded by Mrs. Brown-Curry, to accept the Superintendent's recommendation for student expulsions Items 1 through 10, was approved 4 to 0, with Mr. Boone absent for vote.
