### INVOCATION AND PLEDGE OF ALLEGIANCE

### I. CALL TO ORDER/ADOPTION OF AGENDA

Mrs. Hightower called the Regular Meeting to order at 5:35 p.m. The Superintendent noted the additions, deletions, amendments, and/or corrections outlined on the agenda. ### 2. Stellar Employee Recognition

### 3. National Hunger and Homelessness Awareness Week – Resolution

The Superintendent read the following resolution:

WHEREAS, the theme of the National Hunger and Awareness Week 2007 is "Bringing America Home," and WHEREAS, the Waterfront Rescue Mission recognizes that hunger and homelessness continues to be a serious problem for many individuals in Pensacola; and

WHEREAS, the intent of National Hunger and Homelessness Awareness Week is consistent with the activities of the Waterfront Rescue Mission;

NOW, THEREOFRE, BE IT RESOLVED, that the School Board of Escambia County does hereby recognize the week of November 11-17, 2007 as

and encourages all students and citizens to recognize that many people do not have housing and need support from their local community, and nonprofit service entities.
