INVOCATION AND PLEDGE OF ALLEGIANCE

Mr. Jeff Bergosh gave the invocation and Mrs. Hightower led the Pledge of Allegiance to the United States of America.

PUBLIC FORUM

Mrs. Hightower called the Public Forum to order at 5:30 p.m.; however, there were no speakers.
