Hot dogs being hot held at the distribution point at too low of a temp. The temp was measured at 87 degrees. The hot dogs were discarded.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
