**Violations Comments**

Violation #22. Cold holding temperatures

Cold held TCS food held above 41°F. Cheese stick and milk carton at 45°F in breakfast bag stored in potable cooler inside of the walk-in cooler. The coolers are not stocked with ice or an ice pack and cooler lids are in the closed position. Coolers are overpacked. Ensure that coolers stocked with TCS foods are supplied with ice/ice packs or that the cooler lids are left in the open position when stored in the walk-in cooler. To ensure sufficient temperature control avoid over packing coolers. Follow the manufacture's recommendations for use (i.e. prechilling portable coolers, etc. ).

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
